Community Gardens

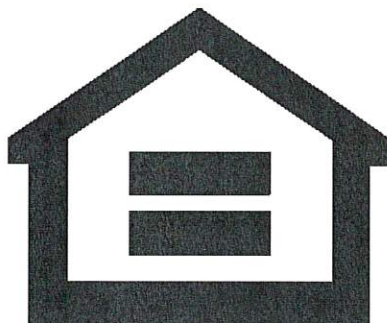
